The Chairman opened the meeting welcoming everybody. The Chairman stated that there is an additional item to the agenda noted as 8a Correspondence.

There were two residents at the meeting, issues raised:--

The fencing near Paddock View,----- replacement of damaged wood to be arranged.

Amount of rubbish being dumped along Fen Road,---- being investigated

Pot Holes were mentioned ----- Highways aware

There was a declaration of interest on item 9 Planning from Councillor Lesley Reeson

Our Lincs County Councillor Mrs Wendy Bowkett did not attend but did send a report:--

The report was sent by email a summary is :-- The Lincolnshire budget for 2018 /2019 will be £455M including money for young and old support, plus £3M for pot holes, the tax rise will be 2.95% plus 2% for adult care = £4.95% rise. The government had given an extra £9M for pot holes, (an extra 2 man team), also in Stickford, work on Back Lane drainage and Black Drove for carriageway reconstruction, also offered assistance on any local LCC issues.

Our ELDC Councillor Mr Jim Swanson

Councillor Swanson stated that the final tax for the coming year should be about 3.75%, but the final meeting is due next Thursday 8 March. There was the possibility of a small allowance of £1500.00 being reinstated to ELDC Councillors in support of local needs and projects.

Wright Eggs Ltd. Planning Application S/204/00210/18. Land at Poplar Farm, Mill Lane, Keal Cotes

Application to vary condition no. 8 regarding passing places on highway as imposed on planning permission reference no. S/204/01679/16

Parish Council were asked by ELDC to comment on the proposed reduction of the number of passing places from 3 to 2. The Parish Council consulted Lincolnshire County Council and was told by Highways they do not consult with the Parish Council regarding where the passing places were to be situated. This made it impossible for the Parish Council to comment on the proposal and was mentioned in the submitted reply. Lincolnshire County Councillor Wendy Bowkett to be notified of the situation.

Financial Matters.

The RFO has not sent out any letters regarding any grants that may have been awarded by the parish council in their application for the precept. The reason is that the council may not get its proposed amount, therefore it was considered not to send letters until precept application was guaranteed to be paid in full. If for any reason full precept is not paid, the council will have to revise any grants applied for.

The RFO presented 3 pages of account detail up dated

There were two bills to pay:-

Community centre rent £48.00

Clerk Expenses £34.97

The RFO reported that there will be changes to the way we claim VAT but we are still waiting for the detail.

Farming Allotments update

After a meeting inviting all allotment holders to discuss the three-yearly review of the allotments. It was formally agreed during the meeting the clerk will send a letter confirming the details of the proposed changes, in 2019. The issue of drainage was discussed and the cost to resolve the problem. It was suggested a site meeting with Wester Power would be helpful. Who has to pay for the drainage will be discussed at a later date.

War Memorial Clock update

Both the Chairman of the Council and other interested parties are attempting to find the solution into getting the clock working again. The Chairman contacted another clock repairer who declined as he did not repair turret clocks. Another repairer in Woodhall Spa will be contracted to find out if he provides a free estimate.

The Parish Council will be advertising for a Volunteer Gardener for the War Memorial Garden.
